TABLE OF FEES AND PAYMENTS FIXED AND SETTLED IN ACCORDANCE WITH THE LOCAL GOVERNMENT ACT 1972 (SCHEDULE 26) DISCHARGE OF FUNCTIONS OF BURIAL AUTHORITIES AND THE LOCAL AUTHORITIES CEMETERIES ORDER 1974 (NO. 628)

The fees and payments below apply where the person to be interred or in respect of whom the right is granted is, or immediately before death was an inhabitant or parishioner of the Parish of Mablethorpe, Trusthorpe or Sutton-on-Sea or in the case of a still-born child, where one of the parents is, or at the time of interment was a parishioner. In all other cases the fees and payments will be doubled, except that those set out in Parts 1 and 3 will not be doubled where the exclusive rights of burial in the grave in question were acquired at time of the single fee set out in Part 2.

PART 3: MONUMENTS AND GRAVESTONES

For the right to erect or place:

(i) A headstone not exceeding 75 cm high x 65 cm wide with or without a vase:	135.00
(ii) Non-standard or double-sized headstone Subject to request and approval	265.00
(iii) A cremation plaque not exceeding 50 cm long x 36 cm wide:	105.00
(iv) A plaque within the garden of remembrance (including plaque purchase and fixing)	70.00

The fees indicated above include the first inscription. Any additional inscription will be subject to a further charge of **£55.00**
